Camp Information:

- If any camper **cannot attend the entire 6 weeks** or will be **absent for more than one week**. They do not qualify for the discounted rate. Additionally, campers must be signed-in daily for **6 hours or more to be in full attendance**. Campers risk being withdrawn from the program if they are not in full attendance every day. If campers are present for less than 6 hours for more than one day, the student can be released from the program.
- Camp fees will not be pro-rated. If a camper attends one day within the week, they are billed for the entire week.
- Discounted fees only apply the first 6 weeks of camp. The last two weeks July 23rd and July 30th normal camp fees of \$75 per week apply.
